<p>課程目標</p> <p>經由社會學的視角，本課程介紹性別研究論述、方法和相關研究，並討論性別及女性主義知識的建構。主要的目的在提昇同學們的專業視野、思考及研究能力；檢視自我的性別經驗，分析社會建構性別議題的過程，關懷日常生活中性別議題，培養對性別的尊重與公正的態度。</p> <p>一、本課程邀請我們檢視、反思並分自我的性別經驗，經由認識了解自我與他（她）人的性別經驗，一起檢視批判既有性別文化，以具備應用專業知能探究與批判性別現象的能力，更培養對差異的尊重與尋求正義的態度。</p> <p>二、本課程啟發並提昇學習者性別議題批判與分析的專業視野，思考及研究能力，培養兼具分析力、綜合力、執行力的性別研究專業人才。</p> <p>三、本課程透視社會體制中性別（以及族群、性別、階級交錯）不平等問題，協助學習者具備理解多元族群文化、性別與社會階級平等之觀點，以多元的視野參與性別平權行動的能力。</p> <p>四、本課程期望經由閱讀及討論，啟發我們對於性別、社會學與多元文化教育的認識、檢視與分析，更具備主動積極與跨領域專業社群團隊合作，具備社會學或多元文化教育女性主義精神的實踐能力。</p>
